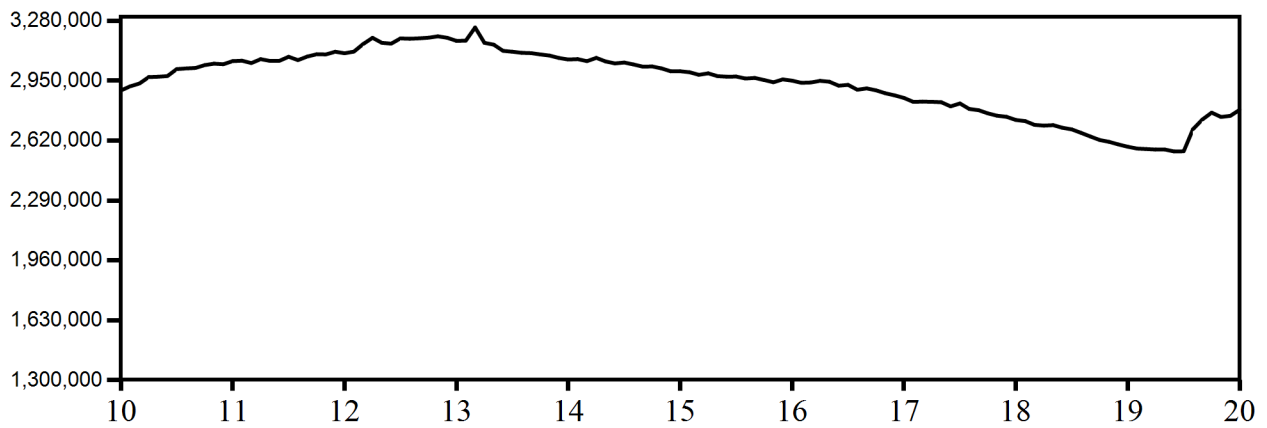

TEN YEAR TREND

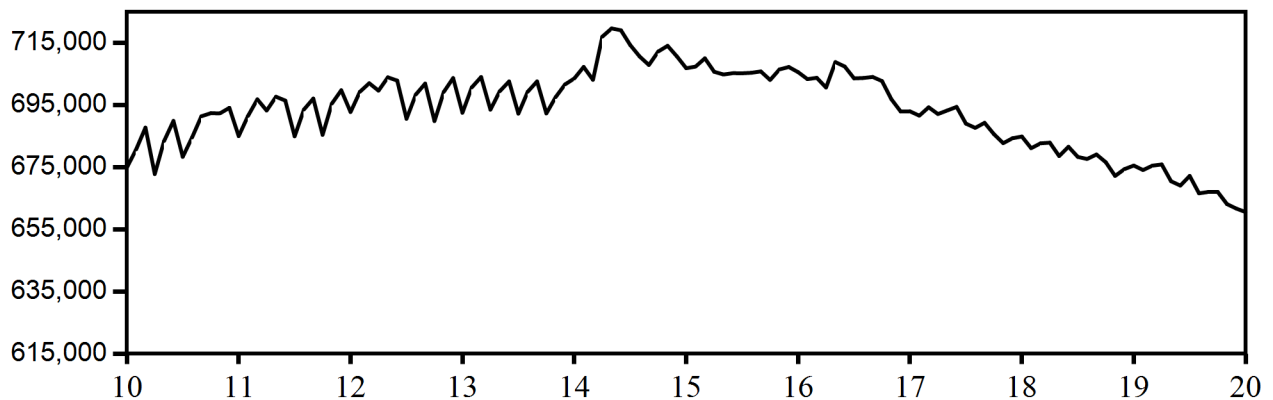
